# Steward of the Land AWARD

## Eligibility Requirements:

1. Nominees (either individual farmers or families) must be living and actively farming in the United States.
2. Preference will be given to nominees who (a) use farming practices that lead to a productive farm in a healthy environment, (b) work to develop policies and programs for farmland protection at the local, state and national levels and (c) demonstrate leadership by protecting their own farm or ranch from development.
3. Individuals or families may not nominate themselves. **Current or former AFT staff and Board members may not participate in any way.** Past nominees who wish to compete for this year's award need not submit new nominations; however, they must contact AFT and may provide updated information in order to be considered for the 2007 award.
4. Nominees need not be AFT members, but they must support AFT's mission and program objectives.

## Nomination Instructions:

Nominators should fill out the reverse side of this sheet and use it as the first page of the nomination packet. Answers to all questions must be typed on separate pages and attached to the first page. Nominators may also include supporting materials such as newspaper clippings, letters or other documents. The entire nomination (including this sheet) should not exceed 10 pages and must be easily reproducible in an 8-1/2" x 11" format. The 10 pages of the nomination should be one-sided. All nominating materials become the property of AFT and cannot be returned.
